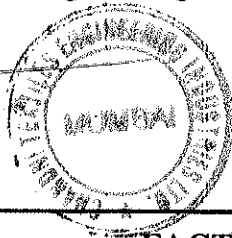

SUMMARY OF THE PROCEEDINGS OF THE 35th ANNUAL GENERAL MEETING (AGM) OF CHANDNI TEXTILES ENGINEERING INDUSTRIES LIMITED

The 35th Annual General Meeting ("AGM") of the members of Chandni Textiles Engineering Industries Limited was held on Monday, 20th September, 2021 through Video Conferencing (VC) or Other Audio Visual Means (OAVM) as per the relaxation given by Ministry of Corporate Affairs vide General Circular No 20/2020 dated 05th May,2020 read with General Circular No. 14/2020 dated 08th April, 2020, General Circular No. 17/2020 dated 13th April,2020 and General Circular No. 02/2021 dated 13th January, 2021 and the meeting commenced at 04:00 PM. The meeting got concluded at 04:15 PM on the same day.

Proceedings in brief:

- Mrs. Khushboo Shah, Company Secretary and Compliance Officer of the Company welcomed the Shareholders/Members and she also informed that 35th AGM of the company is being held through video conferencing as permitted by Ministry of Corporate Affairs. She also assured that the Company had taken all the efforts feasible under these circumstances to enable the members to participate and vote on the items being considered in the meeting.
- It was informed that soft copy of Annual Report of the Company for the Financial Year 2020-2021 has been emailed to all the shareholders/members of the company whose email ids are registered with the Depository Participants.
- The Notice convening 35th AGM was taken as read with the consent of the Members present.
- She informed the members that Mr. Ashutosh Somani, Scrutinizer was also present at the Meeting along with all the Directors from their respective locations.
- It was informed to the members that Mr. Ashutosh Somani, Practicing Chartered Accountant was appointed as the scrutinizer for the purpose of scrutinizing the e-voting at the Meeting and remote e-voting process.
- She informed that the Company had tied up with Central Depositories Securities Limited (CDSL) to provide facility for voting through remote e-voting, e-voting during the AGM and participation in the AGM through VC/OAVM facility.
- She informed the members that the e-voting commenced from Friday, 17th September,2021 (09:00 AM onwards) and ended on Sunday, 19th September, 2021 till 05:00 PM.
